1. 19/0856/HOUSE Longside, The Hollow
Erect replacement Garage, (demolish existing and lower ground of driveway) Note: Amended plans
2. 19/0918/HOUSE Rosemary Cottage, High Street
Replace roof on single storey extension with slate and install rooflights. Remove painted timber cladding and replace with red cedar cladding to walls. Install additional windows and double doors.
3. 19/1038/HOUSE Two Ways, The Hollow
Demolition of single storey lean-to structure and erection of single storey extension to the rear. Part demolition of existing boundary wall.
4. 19/1066/HOUSE Holdaway House, Shaftesbury Road
